A look at what is happening in Cleveland and Bradley County Schools

All members of the Bradley County School Board attended the March meeting held on the 12th. The following are highlights from that meeting.

The board approved field trips for the BCHS Choir to perform for the Abraham Lincoln Bi-Centennial Celebration and other venues in Washington, DC April 22-26 and for the WVHS oceanography class to go to Orlando, FL April 2-6.


During Director of Schools, Johnny Mc-Daniel's good news report, he made the following statement in regards to reading. "Bradley County Schools has been selected to receive the Renaissance Learning National Reading Achievement Award. This award recognizes select school districts exhibiting a deep commitment to excellence in student reading. According to AR host data, for the 2008-2009 school year, students took an average of 95 quizzes per student - far exceeding the national average of 24 tests per student. As of February, Bradley County students had read over 455,700 books." Bradley County Schools are in line for receiving special recognition for reading over one million words.

McDaniel gave recognition to the 2009 Bradley Central High School Bears State Champion Wrestling Team. The wrestling team are the traditional state champions and dual state champions for 2009. They have won 19 state championships (traditional and/or dual) since 1994, have a 24-0 dual record for the season, and are winners of all seven tournaments entered this season. They have extended their unbeaten streak to 46-0 over a two-year period and extended their home winning streak to 16 years with a 123-0 record. Since 1994,

the team has had three individual state champions and eight state place winners.

Johnny Mull of the land search committee updated the board on three potential properties for a new school in Southern Bradley County. The land search committee has narrowed their search down to three potential properties in which the owners are willing to sell. The properties are located near Baugh Springs and Bancroft Road, South Lee off of Johnson School Road, and another is closer to the S. Lee Hwy. side of Bancroft Road.

Architect David Brown presented the board with four schemes to choose from for the Valley View Elementary School renovation. Board member Christy Chritchfield made the motion to accept scheme C because it is all brick and a more classic look that will withstand 50+ more years, unlike stucco. With a sec-

ond from board member Richard Baker, the motion passed unanimously.

Architect Derek Martin gave a presentation of the budget for the new elementary school on Minnis Road which was still within budget. However, the board voted to purchase a sloped, shingle roof and expand the gymnasium to seat 560 students instead of the original plan drawings which would only seat 280 students.

The board is also looking into the benefits of having a geothermal unit installed in the new school.

Chairman David Kelley wants the board to form a committee to allow them to go through the process of naming the new elementary school at Minnis Road. He appointed board member Charlie Rose as the chairman of that committee and also recommended that the committee have representation from the county commission preferably from the 4th district. The committee is to report back to the board by June 2009 with more than one recommendation for a name.
